Sir,

The Custodian submits that auditors were appointed by this Hon'ble Court in respect of parties notified by the Custodian under Section 3(2) of the Special Court (Trial of Offences Relating to Transactions in Securities) Act, 1992. The Audit Reports have been submitted to the Court for a number of notified parties while they are expected to be received shortly in the remaining cases.

The Custodian is making this Report seeking directions for issue of Public Notice calling for claims against all notified parties except Fairgrowth Financial Services Limited (FFSL), to be submitted within such period as this Hon'ble Court may direct. These orders are not being sought in respect of Fairgrowth Financial Services Limited (FFSL) since this Hon'ble Court vide order dated 22nd June 2005 on the Custodian's Report has already directed issue of such public advertisement giving a period of 8 weeks. A copy of this order dated 22nd June 2005 is enclosed herewith as Exhibit 'A'. The Custodian submits that issue of public advertisement at this stage in respect of all notified parties except FFSL would help in crystallising the liabilities of the notified parties so that the process of distribution could be initiated.


The Custodian, therefore, prays as follows:

- that this Hon'ble Court may direct issuance of a Public Notice calling for claims against all notified parties except FFSL.
- That this Hon'ble Court may fix a time limit from the date of Public Notice for lodgment of claims with Custodian in response to such Public Notice.
- That this Hon'ble Court may direct that no claims would be entertained if they are not lodged within a period stipulated in (b) above.
- For such other directions as this Hon'ble Court may deem fit
